Objective:

The fund's investment objective is to provide a high level of current income. Its secondary investment objective is capital appreciation.

Distinguishing characteristics:

An income-oriented strategy that invests in a broad range of traditional U.S. dollar denominated, diversified, income-generating asset classes. Designed as a relative value credit fund, the fund seeks to take advantage of investment opportunities across high yield, investment grade and securitized sectors, while pursuing lower downside risk and volatility that may be more present in common single sector high income funds. With a focus on fundamental analysis coupled with a rigorous relative value approach to sector allocation, the fund aims to generate high income across market cycles.

Morningstar Multisector Bond Category Average: Multisector-bond portfolios seek income by diversifying their assets among several fixed-income sectors, usually U.S. government obligations, U.S. corporate bonds, foreign bonds, and high-yield U.S. debt securities. Morningstar Category averages are designed to represent the average return of funds within their category over time. The daily category averages are calculated daily and reconstituted monthly. Distribution Rate 12-Month: The income per share paid by the fund over the past 12 months to an investor from dividends (including any special dividends). The distribution rate is expressed as a percentage of the current price. Credit Default Swap Index: The credit default swap index (CDX) is a benchmark financial instrument made up of credit default swaps (CDS) that have been issued by North American or emerging markets companies. Credit default swaps act like insurance policies offering a buyer protection in case of the borrower's default. Yield Annualized 30-Day SEC: The 30-day SEC yield reflects the rate at which the fund is earning income on its current portfolio of securities calculated according to the standardized SEC formula; when applicable, it reflects the maximum sales charge.
