The fund's investment objective is to provide current income, consistent with a short duration profile as described in the prospectus and with the preservation of capital.


Distinguishing characteristics:

Focused on current income while maintaining low interest rate exposure, this fund invests primarily in a high-quality mix of U.S. government bonds, corporate bonds, asset-backed and mortgage-backed securities. It seeks a higher income profile than enhanced cash investments with structurally less interest rate exposure than intermediate bond funds. Its flexible and research-driven approach is designed to produce a high-quality portfolio that is diversified across sectors and has the potential to offer attractive income while still preserving capital.
