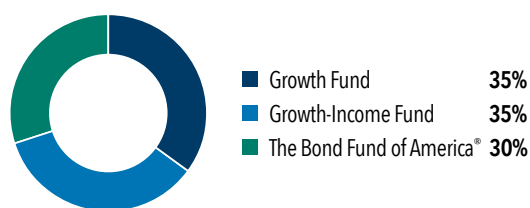


Portfolios for variable annuity investors
