Model description

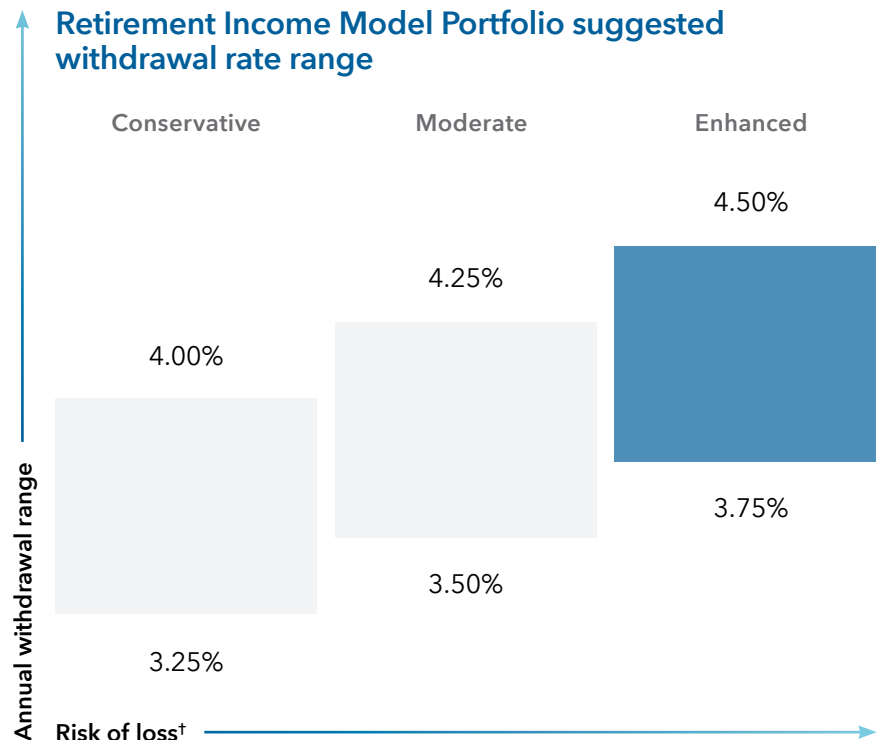
Seeks to support sustained, inflation-adjusted withdrawals and the accomplishment of three investment objectives: current income, long-term growth of capital and conservation of capital. Emphasis is placed on income and growth of capital, through allocation to primarily income-focused equities, as well as fixed income. Uses active Capital Group exchange-traded funds (ETFs) and passive ETFs.

- Are in, or near, retirement and want an investment that supports periodic withdrawals while seeking to preserve as much principal as possible.
- Desire a potentially higher level of income and growth of capital in exchange for potentially greater downside risk.
- Seek the tax advantages of the ETF vehicle and greater transparency of the underlying holdings.
- Value diversified active strategies managed by experienced portfolio managers, complemented by passive investment strategies, to help them accomplish their goal.

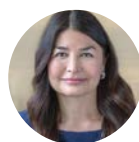
