To provide a high level of current income as is consistent with the preservation of capital.

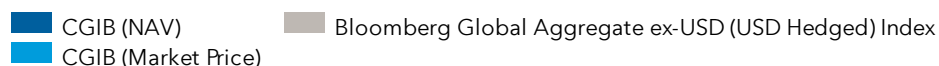
### Distinguishing characteristics:

This international bond strategy seeks to offer investors access to attractive investment opportunities outside of the U.S. to pursue income and capital preservation. A strategy that focuses on non-U.S. core bonds may help provide diversification from U.S. equities and U.S. fixed income. This could potentially bring more sources of return in a portfolio.
