Management's discussion of fund performance

The fund's Class F-3 shares gained 23.16% for the year ended October 31, 2025. That result compares with a 22.64% gain for the MSCI ACWI (All Country World Index). 
What factors influenced results

Global equity markets posted robust gains over the fiscal year, overcoming volatility from trade tensions and geopolitical uncertainty. All major regions delivered positive returns, with non-U.S. markets outpacing the U.S. throughout 2025. While U.S. equities benefited from strong tech earnings and large-cap growth, they slightly trailed the broader global rally. Within emerging markets, equities in China, Taiwan and Korea rallied sharply, more than offsetting the modest decline in India.

Equities domiciled outside the U.S. remained a sizeable portion of portfolio holdings and outpaced domestic stocks. U.S. equities also had strong returns during the period. From a sector perspective, information technology, industrials and communication services were key contributors to returns for the year.


