Management's discussion of fund performance

The fund's Class C shares gained 21.74% for the year ended October 31, 2024. That result compares with a 38.02% gain for the S&P 500 Index. For information on returns for additional periods, including the fund lifetime, please refer to capitalgroup.com/mutual-fund-returns-C.

What factors influenced results

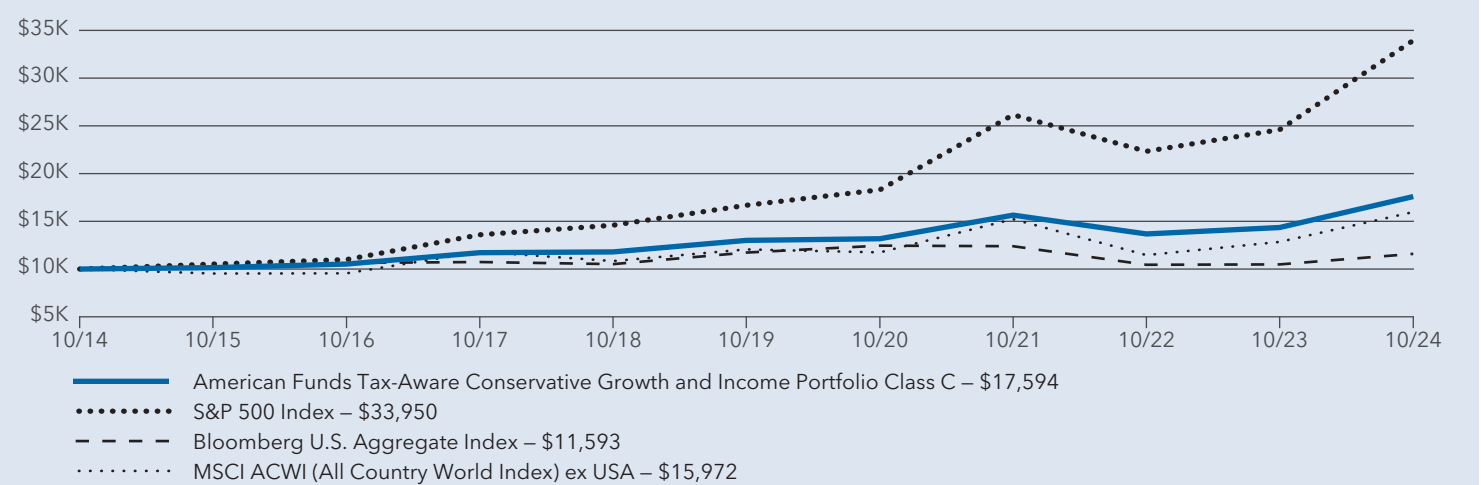
The U.S. economy continued to grow during the fund's fiscal year, and with inflation easing, the U.S. Federal Reserve began instituting interest rate cuts late in the period. Equities posted strong gains, while bond investors enjoyed higher yields for much of the period.

The fund's focus on domestic, dividend-paying equities offered strong overall returns for the fiscal year. Bond returns favored longer durations and high-yield issuers.

Overall, the portfolio's municipal bond holdings, which can offer stability, income and potential tax advantages, saw lower returns than that of the overall portfolio.

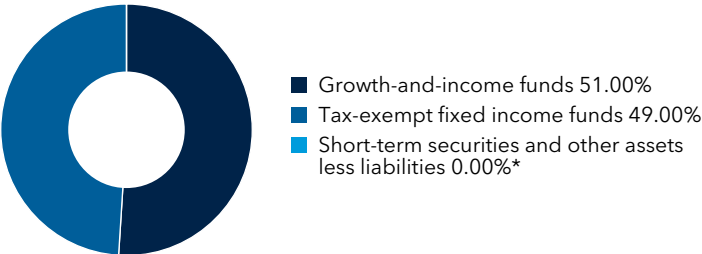
