Model portfolios allocation changes

The initial allocation and subsequent reallocation of underlying funds within these portfolios are a result of deep, fundamental research and the best thinking of Capital Group's investment professionals, specifically the Portfolio Solutions Committee and Capital Solutions Group. Not all models experience allocation changes at the same time. For those that have not changed, their respective allocations are reconfirmed to align toward the model's long-term objectives. The first column for each model represents the model's target allocation at model composite inception, while the last represents the model's current target allocation as of the date listed. Models with only a single column have not yet experienced a change in allocation.
