Management's discussion of fund performance

The fund's Class 2 shares gained 10.19% for the year ended December 31, 2024. That result compares with a 12.43% gain for the 70%/30% MSCI All Country World Index/Bloomberg U.S. Aggregate Index. What factors influenced results

During the fund's fiscal year, U.S. economic growth remained solid, driven by strong consumer spending despite the uncertainties of the presidential election, high interest rates and a slowing labor market. Europe saw modest GDP growth, while the U.K. economy contracted. Japan's growth was steady, China faced stagnant consumption and rising debt, and India showed strong growth but struggled with inflation. Global bond funds had record-level inflows and easing inflation enabled central banks to lower interest rates.

Over the period, the fund's equity holdings in information technology, industrials and financials were particularly additive to the fund's total return, as were holdings domiciled in the U.S. and the Pacific ex-Japan region.

Conversely, equity holdings in the materials and real estate sectors saw negative returns for the period, as did equities domiciled in Japan. The fund's fixed income holdings showed positive returns, though less than the overall portfolio average. High-yield bonds offered the best returns during the period.


Effective July 24, 2024, the fund's primary benchmark changed from the 70%/30% MSCI All Country World Index/Bloomberg U.S. Aggregate Index (the "Previous Primary Benchmark") to the MSCI ACWI (All Country World Index), a broad-based index that represents the overall applicable securities market, as required by the SEC. The Previous Primary Benchmark provides a means to compare the fund's results to a benchmark that the investment adviser believes is more representative of the fund's investment universe. There is no change in the fund's investment strategies as a result of the benchmark change.
