Management's discussion of fund performance

The fund's Class 4 shares gained 31.29% for the year ended December 31, 2024. That result compares with a 25.02% gain for the S&P 500 Index. For information on returns for additional periods, including the fund lifetime, please refer to capitalgroup.com/AFIS-returns-4.

What factors influenced results

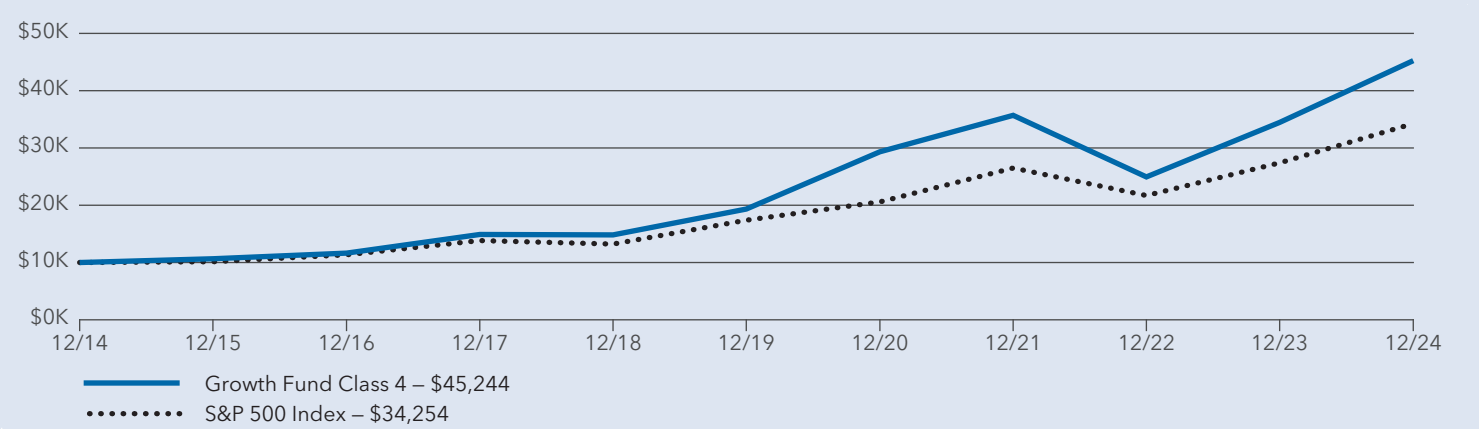
During the fund's fiscal year, U.S. economic growth remained solid driven by strong consumer spending. Headwinds to the market included uncertainty surrounding the presidential election, higher interest rates and slowing job growth. However, the market appeared largely unbothered by inflation remaining above the U.S. Federal Reserve's (Fed) target as well as an expanding government budget deficit. Speculation surrounding the pace and magnitude of the Fed's rate cuts was a primary driver of market returns.

Overall, most sectors added to the fund's positive results with communication services and information technology holdings leading the way. Likewise, returns among the fund's consumer discretionary and financials holdings surpassed those of the overall portfolio, contributing to relative results.

In terms of detractors, holdings in the energy and consumer staples sectors weighed on the fund's relative results.

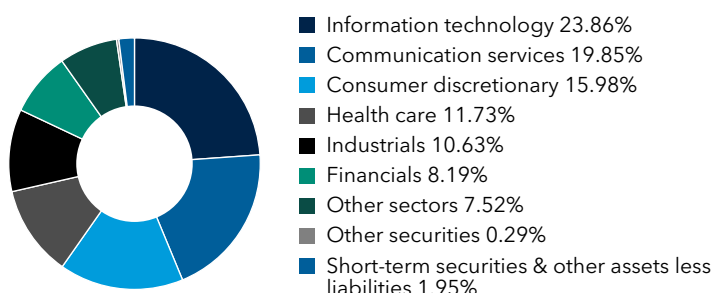
