Management's discussion of fund performance

The fund's Class 4 shares lost 3.32% for the year ended December 31, 2024. That result compares with a 1.69% loss for the Bloomberg Global Aggregate Index. For information on returns for additional periods, including the fund lifetime, please refer to capitalgroup.com/AFIS-returns-4.

What factors influenced results


During the fund's fiscal year, the global bond market experienced record-setting inflows as investors poured assets into developed and emerging markets bond funds, seeking to lock in some of the highest starting yields in decades. Additionally, easing inflation across many global regions enabled central banks to lower interest rates, offering investors the potential for price appreciation.

The fund's less-than-benchmark holdings in Japanese government bonds contributed to its comparative returns, as did its greater-than-benchmark holdings in the Federal Home Loan Mortgage Corporation (Freddie Mac). Off-benchmark allocations to Egyptian and Argentine government bonds also contributed to the fund's results. Sector and currency allocations further supported the fund's comparative returns.

Conversely, the fund's off-benchmark allocation to Brazilian government bonds detracted from results. Less-than-benchmark positions in uniform mortgage-backed securities (MBS) and U.S. Treasury bonds were also notable detractors from comparative results. In addition, currency management and duration positioning weighed on returns. Duration positioning refers to the strategic management of a portfolio's overall sensitivity to interest rate changes by adjusting the weighted average duration of its constituent bonds.


