General information

Contact your financial professional to obtain a current prospectus or summary prospectus for each fund you select. If investing in CollegeAmerica® or ABLEAmerica®, you must also obtain a Program Description. To learn more about the funds, visit our website at www.capitalgroup.com.

You may process transactions by visiting our website at www.capitalgroup.com or by calling (800) 421-4225. Requests received after 4 p.m. Eastern time will be transacted at the next business day's closing price. If you have linked your bank account to your American Funds account, your bank account should be debited or credited within three business days after the transaction date. Investment and withdrawal limits apply. See the fund prospectuses for more information.

Fund minimums

The following fund minimums apply to initial investments.

- \$1,000 each for money market, interval and state-specific tax-exempt bond funds
- \$250 each for all other funds
- \$25 each for employer-sponsored accounts and payroll deduction programs

For accounts funded via an automatic investment plan, fund minimums must be met within the first five months of account establishment.

Share class descriptions

Class A shares have an initial sales charge of up to 5.75% (lower for bond and interval funds and none for the money market fund) that declines as the amount invested increases, as described in the fund prospectuses.

Class 529-A and Class ABLE-A shares have an initial sales charge of up to 3.50% (none for the money market fund) that declines as the amount invested increases, as described in the fund prospectuses.

Class C and Class 529-C shares do not have an initial sales charge, but have expenses that are higher than Class A or Class 529-A shares and a 1% contingent deferred sales charge on shares sold within one year. Class C and Class 529-C shares are available for investments of \$500,000 or less per individual transaction. Shareholders whose combined American Funds assets are \$1 million or more may not invest in Class C or Class 529-C shares. For conversion rules, see the fund prospectuses.

Class 529-E shares are available only for employer-sponsored CollegeAmerica accounts.

Class F-1, Class F-2, Class F-3, Class 529-F-2 and Class ABLE-F-2 shares are available only through participating Investment Advisor Representatives or participating intermediaries. These share classes do not have an initial or contingent deferred sales charge. Class 529-F-2 shares are available only for CollegeAmerica accounts. Class ABLE-F-2 shares are available only for ABLEAmerica accounts. Class F-3 shares available to institutional clients require \$1 million or more invested per fund.
