Distinguishing characteristics:

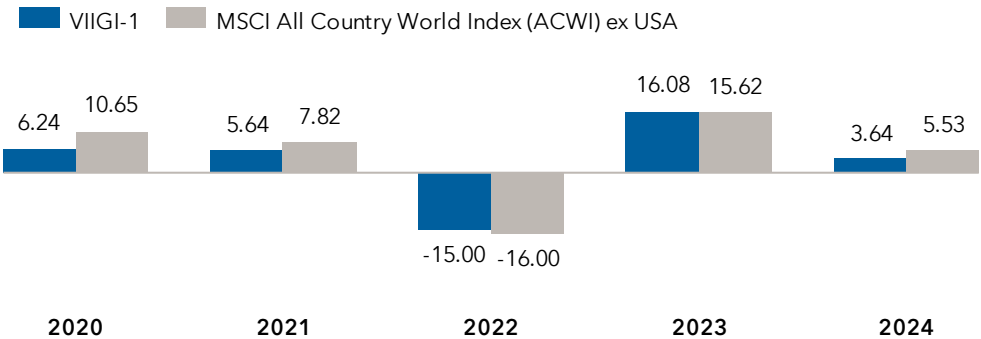

It focuses on well-established companies with strong earnings that often pay dividends, which can help reduce volatility. Historically, its dividend-income focus has helped the strategy provide less volatility than its peers.

Non-U.S. holdings:

The fund invests at least 90% of assets in companies based outside the U.S., including developing countries.

Standard Deviation: Annualized standard deviation (based on monthly returns) is a common measure of absolute volatility that tells how returns over time have varied from the mean. A lower number signifies lower volatility. **Distribution Rate 12-Month:** The income per share paid by the fund over the past 12 months to an investor from dividends (including any special dividends). The distribution rate is expressed as a percentage of the current price. **AFIS International Growth and Income Fund Historical Benchmarks Index:** American Funds Insurance Series International Growth and Income Fund Historical Benchmarks Index returns reflect the results of the MSCI World ex USA Index through 12/31/2011 and the MSCI All Country World ex USA Index, the fund's current primary benchmark, thereafter. A measure of 100 indicates that all of the return can be explained by movements in the benchmark. Generally the higher the R-squared measure, the more reliable the beta measurement will be. **Beta:** Beta relatively measures sensitivity to market movements over a specified period of time. The beta of the market (represented by the benchmark index) is equal to 1; a beta higher than 1 implies that a return was more volatile than the market. A beta lower than 1 suggests that a return was less volatile than the market. Generally the higher the R-squared measure, the more reliable the beta measurement will be. **Portfolio turnover:** Portfolio turnover is the portion of a portfolio's holdings sold and replaced with new securities annually, usually expressed as a percentage of the portfolio's total assets. For example, a portfolio with a turnover of 25% holds assets for an average of about four years, while a portfolio with a turnover of 100% holds assets for one year. **MSCI All Country World Index (ACWI) ex USA:** MSCI All Country World Index ex USA is a free-float-adjusted market-capitalization-weighted index that is designed to measure equity market results in the global developed and emerging markets, excluding the United States. The index consists of more than 40 developed- and emerging-market country indexes.
