#### Objective:



#### Distinguishing characteristics:

This broadly diversified global bond strategy invests primarily in sovereign and corporate bonds in more than 60 developed and developing markets. The fund may invest up to 25% of assets in bonds rated below investment grade (BB+/Ba1 and below) at the time of purchase.

Yield Annualized 30-Day SEC: The 30-day SEC yield reflects the rate at which the fund is earning income on its current portfolio of securities calculated according to the standardized SEC formula; when applicable, it reflects the maximum sales charge.
