Distinguishing characteristics:

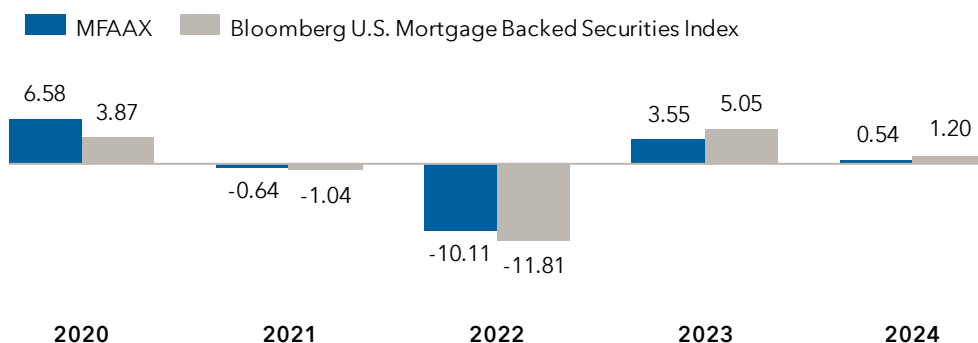
