### Objective:

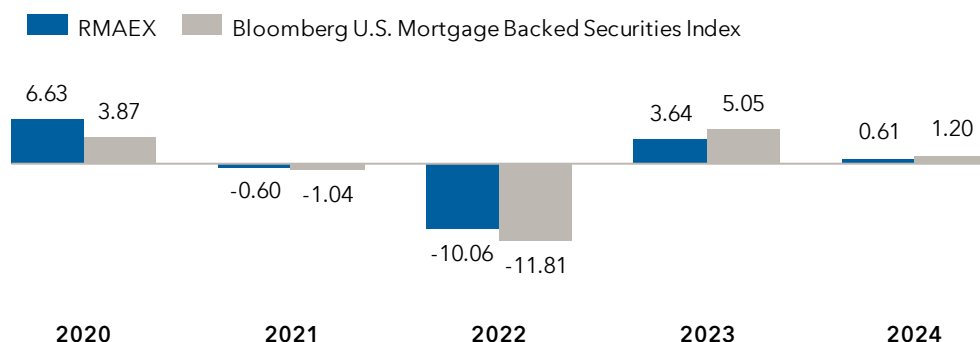
The fund's investment objective is to provide current income and preservation of capital.

This fund seeks to add value by actively managing sector allocation, security selection, duration and yield curve.
