Distinguishing characteristics:

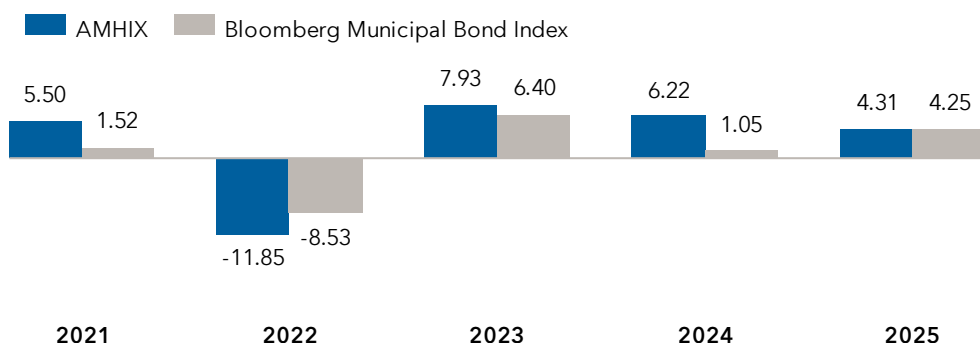
