Objective:

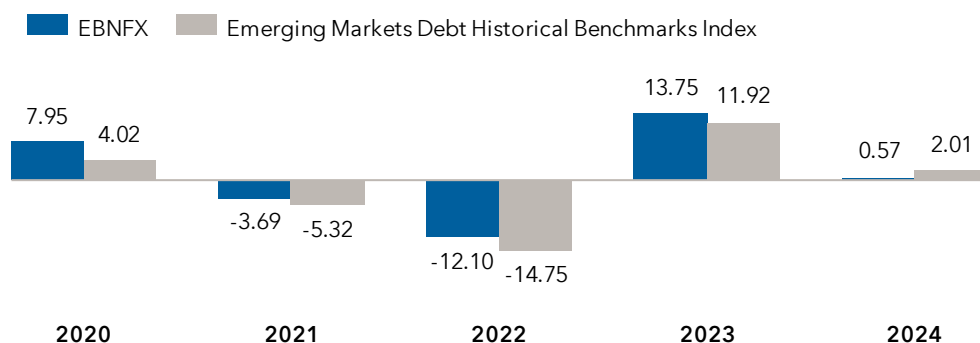
The fund's investment objective is to provide a high level of total return over the long term, of which current income is a large component.

It invests in both sovereign and corporate bonds, denominated in either U.S. dollar or local currency issues, which may serve as a source of favorable returns and potential diversification.
