Objective:

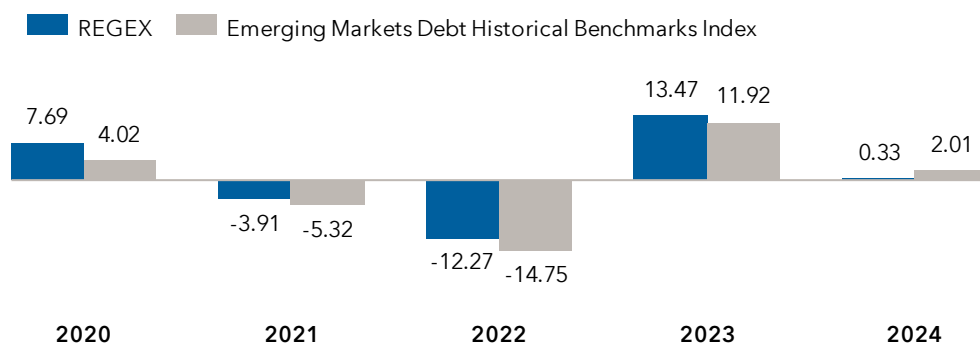
The fund's investment objective is to provide a high level of total return over the long term, of which current income is a large component.

Distinguishing characteristics:
